

# Privacy Policy of Ballarat Area Robotics League (BARL)

Ballarat Area Robotics League, hereafter referred to as BARL, operates the BARL.io website, which provides the SERVICE.

This page is used to inform website visitors regarding our policies with the collection, use, and disclosure of Personal Information if anyone decided to use our Service, the BARL.io website.

If you choose to use our Service, then you agree to the collection and use of information in relation to this policy. The Personal Information that we collect are used for providing and improving the Service. We will **NOT** publish, sell, use or share your information with anyone, or on any 3<sup>rd</sup> party platform, except as described in this Privacy Policy.

## Information Collection and Use

We collect information solely for the purpose of supporting and providing BARL services. Information is provided on a voluntary basis, however personal information is required in order for participation in BARL services.

Personally identifiable information we collect may include;

- Full name;
- Date of Birth;
- Postal Address;
- Contact Phone numbers;
- Email addresses;
- Social media names, handles, addresses;
- Identifying Photographs and Video Recordings;

The information that we collect will be used to contact or identify you in accordance with providing the service. We may;

- Contact you about your entries, events and competitions;
- Send direct promotional and marketing materials via email;
- Publish identifiable photographs and video to the BARL.io website, BARL Social media services and YouTube websites with **informed consent**;
- Publish your Full Name in a publically viewable area inside and during a BARL event;

- Use your Full Name (*Spoken*), in a public area inside and during a BARL event;
- Use information that you have consented to be used or disclosed, in a manner so consented;

## **Log Data**

We want to inform you that whenever you visit our Service, we collect information that your browser sends to us that is called Log Data. This Log Data may include information such as your computer's Internet Protocol ("IP") address, browser version, pages of our Service that you visit, the time and date of your visit, the time spent on those pages, and other statistics.

## **Cookies**

Cookies are files with small amount of data that is commonly used an anonymous unique identifier. These are sent to your browser from the website that you visit and are stored on your computer's hard drive.
